TERAMS AND CONDITION

1. Membership of Legeazy International is not transferable and membership fee is not refundable.

6. Services shall be rendered after 30 days on confirmation of valid membership and only on receipt of stipulated membership fee.
7. Members not availed the services will be entitled for special discount in membership renewal i.e. 10% in 2ndyear, 25% in 3rdyear and 50% in 4th year.
